All that certain piece, parcel, or lot of land, with all improvements thereon or bereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the easterly side of Stallings Road, and being shown as 21.8 acres, more or less, on a plat entitled "Pebble Creek, Phase IV", prepared by Freeland and Associates, May 3, 1979, said plat being recorded in the R.M.C Office for Greenville County in Plat Book 7-A, at Page 66, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Stallings Road right-of-way at the joint front corner of the tract herein described and property of Southern Worsted Mills and running thence along the Southern Worsted Mills property S. 83-48 E. 421.4 feet to an iron pin; thence continuing along the Southern Worsted Mills property, S. 84-05 E. 403.5 feet to an iron pin; thence turning and continuing along the Southern Worsted Mills property, S. 20-58 W. 884.6 feet to an iron pin; thence turning and running along the southern boundary line of the tract herein described, S. 82-29 E. 583.0 feet to an iron pin located in the property line of Property of Pebble Creek Golf and Country Club of Greenville, Inc. (Pebble Creek Golf Course); thence turning and running along the Pebble Creek Golf Course with the golf course boundary as the property line 2,457 feet, more or less to an iron pin on the easterly side of Stallings Road, thence turning and running along the easterly side of Stallings Road, S. 20-40 $\overline{\text{W}}$. 1273.0 feet to the POINT OF BEGINNING.
