ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the east side of E Street, in Section No. 6 of Judson Mills Village, being known and designated as Lot #26 as shown on a plat of Section 6 of Judson Mills Village, made by Dalton & Neves, Engineers, November, 1941, which plat is recorded in the RMC Office for Greenville County in Plat Book K at pages 106 and 107, and having the following metes and bounds, to-wit:
