

BEGINNING at an iron pin on the northern side of Oregon Street, said point being 240 feet, more or less, in a westerly direction from the intersection of Oregon Street and Fuller Street and running thence with Oregon Street, S. 63-35 W., 60.0 feet to an iron pin at the joint front corner of Ltos 3 and 4; thence with the joint line of said lots, N. 26-30 W., 165.0 feet to an iron pin at the joint rear corner with Lot 12; thence with lot 12, N. 63-35 E., 60.0 feet to an iron pin at the joint rear corner of Lots 4 and 5; thence with the joint line of said lots, S. 26-30 E., 165.0 feet to an iron pin on Oregon Street being the point of BEGINNING.

This is the same property conveyed to the mortgagors by Deed of Lewis J. Ewert and Erna E. Ewert dated May 18, 1979.
