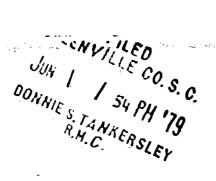

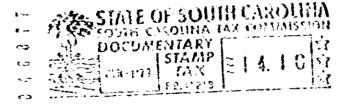

ALL that certain piece, parcel or lot of land with all improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the northwestern side of Conestee Avenue, and being known and designated as Lot No. 16 according to a plat entitled "Cherokee Park" recorded in the Greenville County R.M.C. Office in Plat Book "C" at Page 96, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Conestee Avenue at the joint front corner of Lots Nos. 15 and 16 and running thence with the line of Lot No. 15, N. 62-32 W. 171.3 feet to an iron pin on a 15 foot alley; thence with said alley, S. 27-40 W. 54.1 feet to an iron pin, at the joint rear corner of Lots Nos. 16 and 17; thence with the line of Lot No. 17, S. 62-32 E. 171.7 feet to an iron pin on Conestee Avenue; thence with said Conestee Avenue, N. 27-15 E. 54.1 feet to the beginning corner.
