NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

Office for Greenville County, South Carolina, in Plat Book "C", at Page 176, and having according to said plat the following metes and bounds, to-wit: BEGINNING at a corner of Ladson Street and Mills Avenue and running thence with Mills Avenue S. 45-27 W., 65-feet; thence S. 44-33 E., with line of Lot No. 2, 180-feet to an iron pin on an alley; thence with said alley N. 45-27 E., 65-feet to an iron pin on Ladson Street; thence along Ladson Street N. 44-33 W., 180-feet to the point and place of beginning.
