NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and being known and designated as lot No. 23 of the property known as Nicholtown Heights as shown by plat prepared by W. J. Riddle, surveyor, and is recorded in the RMC Office in plat book M page 5 and having the following metes and bounds to wit:

Beginning at an iron pin on the southwest side of Pine Street at the joint front corner of Lots 22 and 23 and running thence with line of lot 22 S. 56 W. 120 feet, more or less, to an iron pin at the joint rear corner of lot 22, 23, 34 and 35; thence with the line of Lot 35 S. 34-0 E. 40 feet, more or less, to an iron pin at the joint rear corner of lots 23, 24, 35 and 36; thence with the line of lot 24 N. 56 E. 120 feet, more or less, to an iron pin on the southwest side of Pine Street; thence with the southwest side of Pine Street N. 34-0 W. 40 feet, more or less, to the beginning corner.
