All that certain piece, panel, or lot of lead with all improvements thereon or benefiter to be constructed thereon, situate, bring and being in the State of South Carolina. County of Greenville, and being on the eastern side of Rutherford Road (formerly known as Reid School Road) and on the northern side of the right-of-way of P & N Railroad Co., being shown and designated as Tract No. 5 on a survey of the property of Lambert W. Jordan made by Clarkson Surveying, dated June 15, 1979, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point at the intersection of the right-of-way of Jordan Drive and Rutherford Road and running in a northerly direction N. 10-20 8. 30 feet; thence N. 3-34 E. 195.3 feet with the right-of-way of Mutherford Road to its intersection with the line now or formerly of Leslie and Shaw, Inc.; thence turning and running S. 81-36 E. 332.1 feet to an iron pin on the line of property now or formerly of C. H. Matrick & Co.; thence with the Patrick line S. 8-00 E. 141.5 feet to a point at the corner with Lot 4 as shown on the Clarkson Plat; thence with the line of Lot 4, S. 82-00 W.130 feet to a point; thence turning and continuing with the line of Lot 4, S. 14-50 W. 144.4 feet to a point on the right-of-way of Jordan Drive; thence with the right-of-way of Jordan Drive N. 53-02 W. 80.15 feet to a point; thence continuing N. 66-58 W. 70 feet to a point; thence S. 74-38 W. 46.4 feet; thence continuing N. 38-14 W. 43.25 feet to the point of beginning.
