To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the East side of Vaughn Street, and being known and designated as Lot No. 25 of Pleasant View Acres as shown on plat prepared by H. S. Brockman, Reg. Surveyor, dated March 22, 1954, and amended plat has been recorded in the P.M.C. Office for Greenville County, in plat Book "PTW", at page 365, for more particularly description, see the aforesaid plat.

This is the same property conveyed to George O. Tisdale by John D. McClimon by deed dated 1st day July 1961 and recorded in the R.M.C. Office for Greenville County recorded on 5th Day July 1961 in Deed Book 677, at Page 82.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
