THIS MORTGAGE is made this 2nd DONNIE S. TANKERSLEY November
19 79, between the Mortgagor, C. Steven Cooke and Jean D. Cooke
..... (herein "Borrower"), and the Mortgagee,
NCNB MORTGAGE CORPORATION, a corporation organized and existing
under the laws of North Carolina, whose address is P. O. Box 34069,
Charlotte, North Carolina 28234. (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Forty-Three Thousand Five
Hundred and no/100ths (\$43,500.00) Dollars, which indebtedness is evidenced by Borrower's note

State of South Carolina:

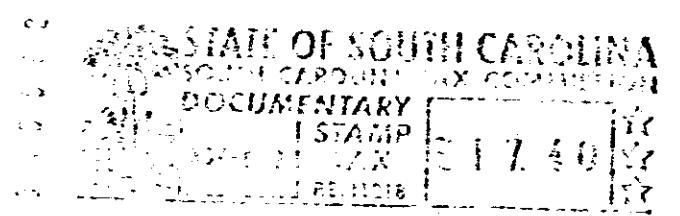
ALL that certain piece, parcel or lot of land, with all improvements thereon or

October 26, 1965 and recorded in the R.M.C. Office for Greenville County in Plat
Book BBB, at Page 137.

AND:

ALL that peice, parcel or lot of land, with all improvements thereon or hereafter
constructed thereon, situate, lying and being in the City of Mauldin, County of
Greenville, State of South Carolina, as shown on a plat entitled "Property of

ments now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral,
oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the
property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the
property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this
Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage,
