

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate. lving and being in the State of South Carolina, County of Greenville, being shown and desiganted as Lot 6 on a plat entitled Section I, Powderhorn, dated July 26, 1973, most recently revised March 1, 1974, prepared by Piedmont Engineers and Architects, recorded in the RMC Office for Greenville County, in Plat Book 4X at page 95, and having such metes and bounds as appear by reference therto. Said lot fronts on the Northeasterly side of a cul de sac on Rabon Court.

This property is conveyed subject to restrictive convenants, if any, and any easements or rights of way affecting same.
