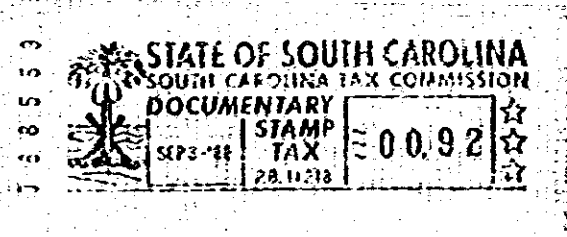
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Boykins Court and being shown and designated as Lot 33 on a Plat of Section 5 of Richmond Hills recorded in the RMC Office for Greenville County in Plat Book WWW at page 35, reference being had to said Plat for a more complete metes and bounds description.

This is a second mortgage junior in priority to that certain mortgage held by Charter Mortgage Company and executed by John Bradford Carnes and Charlotte B. Carnes on September 25, 1979, and recorded on October 2, 1979, in the RMC Office for Greenville County in the REM Book 1482 at page 913 in the original amount of \$42,500.

The above described property is the same acquired by the mortgagors by deed from John Bradford C rnes and Charlotte B. Carnes dated August 29, 1980, to be recorded herewith.
