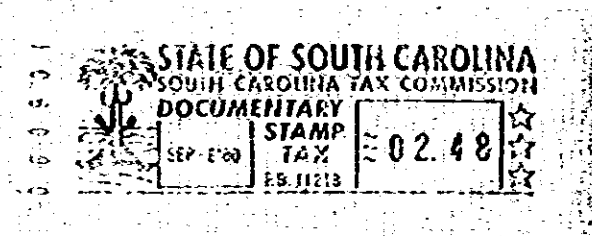
THIS MORTGAGE, made this 1st day of September, 1980, by A. Gerald Stroud  
and Lois C. Stroud hereinafter called the Mortgagor, in the State aforesaid, Witnesseth:

WHEREAS, the said Mortgagor is truly indebted unto UNITED VIRGINIA MORTGAGE CORPORATION, Richmond, Virginia, hereinafter called the Mortgagee, in the sum of Six thousand one hundred twenty-five (\$ 6,125.00 ) Dollars, as evidenced by a promissory note of even date herewith, payable to the order of the Mortgagee in 120 consecutive monthly instalments of One hundred and 70/100 (\$ 100.70 ) Dollars each, the first instalment being due October 15, 1980, and the remaining instalments are due on the 15th day of each month thereafter.

ALL that certain piece, parcel, or lot of land, situate, lying and being on the northeastern side of the Cul-de-sac of Willowtree Court, in the Town of Simpsonville, Greenville County, South Carolina, being shown and designated as Lot 378 on a Plat of WESTWOOD Subdivision, Section IV, made by Piedmont Engineers and Architects, dated June 7, 1972, recorded in the RMC Office for Greenville County in Plat Book 4-R, at Page 30, reference is hereby craved for the metes and bounds thereof.
