To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate lying and being near the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 2 on Plat of North Sunset Hills, said plat being recorded in the RMC Office for Greenville County, SC in Plat Book L, page 92, and having according to said plat, the following meted and bounds, to-wit: Beginning at a stake on the northwestern side of Paris Mountain Road 35 feet northeast from Elizabeth Drive of the corner of Lot No. 1; and running thence with the line of said lot N. 38-38 W. 157.8 feet to a stake on the southeastern side of said strip N. 50-52 E. 60 feet to a stake, corner of lot No. 3; thence with the line of said lot S. 38-38 E. 158.3 feet to stake on Paris Mountain Road; thence with the northwestern side of Paris Mountain Road S. 51-22 W. 60 feet to the beginning corner.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
