

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-Five Thousand Three Hundred Fifty and No/100 (\$55,350.00) Dollars, which indebtedness is evidenced by Borrower's note dated ... ALL that certain piece, parcel or lot of land with all buildings and improvements thereon, or hereafter constructed thereon, situate, lying and being on the eastern side of Brentwood Way in the City of Simpsonville, County of Greenville, State of South Carolina, and being known and designated as Lot 80 on a Plat of Brentwood, Section No. III, prepared by Piedmont Engineers-Architects-Planners, dated November 15, 1973, and recorded in the RMC Office for Greenville County in Plat Book 5D, page 42 on April 5, 1974, reference to said plat is hereby craved for a metes and bounds description thereof.
