To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, on the northwestern side of Enoree Court and being known and designated as Lot 12, on a plat of Enoree Heights, dated August, 1960, prepared by J. Mac Richardson, RLS, and recorded in the RMC Off for Greenville County, South Carolina in Plat Book RR, at page 63, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the northwestern edge of Enoree Court at the joint front corners of Lots 11 and 12 and running thence along a line of Lot 11, N. 75-00 W. 345 feet to a point fifteen feet from the center of a branch; thence along center of said branch as the line by the traverse line, N. 33-17 E. 105 feet to a point; thence S. 75-00 E. 361 feet to a point on the western side of Enoree Court; thence along the western edge of Enoree Court, S. 15-00 W. 100 feet to the point of beginnine. - This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.

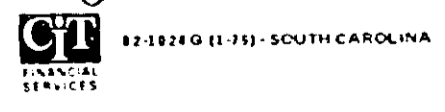
