WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty-seven Thousand Forty and 80/100 DOLLARS (\$27,040.80), with interest thereon from date at the rate of 18 per centum per annum, said principal and interest to be repaid:

in 120 equal monthly installments of \$225.34 each, the first of said payments being due December 4, 1980 and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.

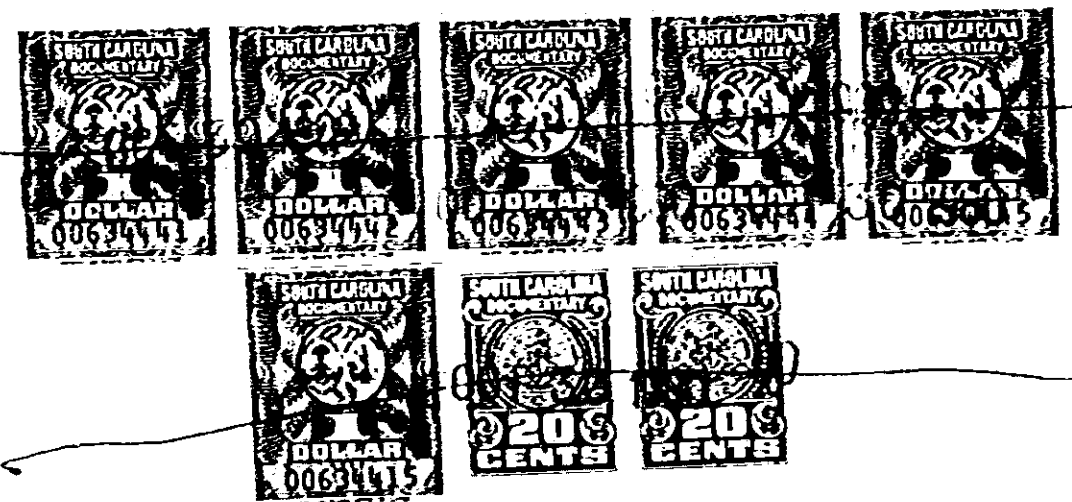

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southern side of Pendleton Street (sometimes referred to as Pendleton Street Extension) in the City of Greenville, being shown as Lot Number 2 of Block D on plat of property of Melville Land Company Subdivision No. 2, made by Lockwood, Greene & Co., dated May 1905, recorded in Plat Book A at Page 97 of the RMC Office for Greenville County.
