MORTGAGE

THIS MORTGAGE is made this 1st day of December, 1980, between the Mortgagor, John Wheeler Anderson and Sandra R. Anderson

JWA SR (herein "Borrower"), and the Mortgagee, Perpetual Federal Savings and Loan Association, ~~whose office is located at 907 North Main Street, Anderson, South Carolina~~ whose address is 907 North Main Street, Anderson, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy Thousand and 00/100ths dollars, which indebtedness is evidenced by Borrower's note dated December 1, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid due and payable on December 1, 2010

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville State of South Carolina.

ALL that certain piece, parcel, or lot of land with the buildings and improvements thereon, lying and being on the southeasterly side of Creekside Road, near the City of Greenville, South Carolina, being known and designated as Lot No. 417 on plat entitled "Map 3, Section 2, Sugar Creek," as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7-X at Page 2, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Creekside Road, said pin being the joint front corner of Lots 416 and 417 and running thence with the common line of said lots S. 50-22-37 E., 139.4 feet to an iron pin, the joint rear corner of Lots 416 and 417; thence N. 43-52 E., 89.28 feet to an iron pin, the joint rear corner of Lots 417 and 418; thence with the common line of said lots N. 41-53-20 W., 139.3 feet to an iron pin on the southeasterly side of Creekside Road; thence with the southeasterly side of Creekside Road S. 43-52-01 W., 110 feet to an iron pin, the point of beginning.
