TO HAVE AND TO HOLD the above described property unto Mortgagee, his heirs, successors, and assigns forever.

To keep the buildings, structures and other improvements now or hereafter erected or placed on the premises insured in an amount not less than the principal amount of the note aforesaid against all loss or damage by fire, windstorm, totnado and water damage, as may be required by than the principal amount of the note anotesaid against an ioss of damage by five, windstolin, tolliado and water damage, as may be required by the Mortgagee, with loss, if any, payable to the Mortgagee as his interest may appear; to deposit with the Mortgagee policies with standard hortgagee clause, without contribution, evidencing such insurance; to keep said premises and all improvements thereon in first class condition and lepair. In case of loss, Mortgagee in hereby authorized to adjust and settle any claim under any such policy and Mortgagee is authorized to collect and receipt for any such insurance money and to apply the same, at Mortgagee's option, in reduction of the indebtedness hereby secured, whether he or not, or to allow Mortgagor to use such insurance money, or any part thereof, in repairing the damage or restoring the improvements or other property without affecting the lien hereof for the full amount secured hereby.
