PURCHASE MONEY MORTGAGE OF REAL ESTATE

WHEREAS, William M. Hinman and Julia G. Hinman
(hereinafter referred to as Mortgagor) is well and truly indebted unto Loyd A.

Dollars (\$/0,00/.4/3) due and payable with interest thereon from March 31, 1980, at the rate of nine percent (9%) per annum to be paid as specified in said promissory note.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

WHEREAS, due to an error in the original plat prepared by Freeland & Associates and recorded in the RMC Office for Greenville County, South Carolina in Plat Book 7W, Page 73, the original mortgage given to secure the above mentioned promissory note the description of the property contained in the mortgage recorded in the RMC Office for Greenville County, South Carolina in Mortage Book 70, Page 30, on April 2, 1980 was in error. This mortgage is being given to correct said error and to replace said original mortgage which shall be canceled of record with the filing of this corrected mortgage.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgage may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to this mortgage and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or tract of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being shown on plat entitled "Loyd A. Smith Life Estate, Tract 3" as prepared by Freeland & Associates dated October 18, 1979, and revised March, 1981, as recorded in the RMC Office for Greenville County, South Carolina in Plat Book 8K, Page 73, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a railroad spike in the center of Roper Mountain Road approximately 566.8 feet from the intersection of Roper Mountain Road and Moore Road and running thence N 16-14 E 392.9 feet crossing a reference iron pin 25 feet from the center line of Roper Mountain Road; thence N 44-52 E 462.8 feet to an iron pin; thence S 32-00 W 305.7 feet to an iron pin; thence S 16-13 W 594.0 feet to a railroad spike in Roper Mountain Road crossing a reference iron pin 25 feet from said railroad spike; thence with the center line of Roper Mountain Road N 73-57 W 450 feet to a railroad spike, the point of beginning, said tract containing a total of 6.678 acres inclusive of road right of ways or a net acreage of 6.4197 acres exclusive of road right of ways.
