C. H. CREWS, JR. and NOAH T. ARROWOOD, SEND GREETING:

WHEREAS, the said C. H. Crews, Jr. and Noah T. Arrowood in and by their certain promissory note in writing of even date with these Presents, we are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Thirty Seven Thousand, Five Hundred and no/100ths (\$ 37,500.00) Dollars, with interest from the date hereof at the rate of fifteen & one-half per cent (15.5%) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of Five Hundred, Seven and 71/100ths (\$ 507.71) Dollars
