Some of the items of property described herein are goods that are or are to become fixtures, and it is intended that, as to those goods, this Mortgage shall be effective as a financing statement filed as a fixture filing from the date of its filing for record in the real estate records of the County and State of the Mortgaged Premises. The Mortgagor is the record owner of all real property described herein.

## 26. Other Security.
