"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on Cunningham Circle (formerly Peach Tree Street) near the city of Greenville and being known and designated as Lot 4, Section 3, Cunningham Acres, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-N at Page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Cunningham Circle (formerly Peach Tree Street) at the joint front corner of Lots 3 and 4 and thence along the joint line of the said Lots, S 93-10 E 165.2 feet to an iron pin; thence along the north boundary of Drexel Terrace, S 86-53 W 110 feet to an iron pin at the joint rear corner of Lots 4 and 5; thence along the joint line of said lots, N 03-10 W 165.1 feet to an iron pin at the joint front corner of said lots on the southerly side of Cunningham Circle; thence along said Circle, N 86-50 E 110 feet to an iron pin at the point of beginning.
