NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the northeastern side of East Earle Street being known and designated as a portion of Lot Number 2 as shown on a plat of "Section F, Stone Land Company", recorded in the RMC Office for Greenville County, South Carolina, in Plat Book K at Page 277, and having, according to a more recent plat entitled "Property of Paul Henry Newton and Betty Jo Newton", dated November 9, 1971, and prepared by Carolina Surveying Company, the following metes and bounds:

BEGINNING at an iron pin on the northeastern side of East Earle Street at the joint front corner of Lots Number 1 and 2 and running thence with the line of Lot Number 1, N. 17-09 E. 130 feet to an iron pin; thence S. 71-20 E. 63.83 feet to an iron pin in the line of Lot Number 3; thence with the line of Lot Number 3, S. 17-09 W. 130 feet to an iron pin on the northern side of East Earle Street; thence with the northern side of East Earle Street, N. 71-20 W. 63.83 feet to the point of beginning.

This is the identical property conveyed to the Mortgagor herein by deed from John Robert Harper and Jeffery Herbert Weaver dated October 31, 1980, and recorded in the R.M.C. Office for Greenville County on November 7, 1980 in Deed Book 1136, Page 938.
