- (4) That it will pay, when duz, all taxes, public assessments, and other governmental or municipal charges, finzs or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged

- (6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgage, all sums then ewing by the Moragagor to the Mortgage shall become immediately due and payable, and this mortgage may be fereclosed. Should any legal preceedings be instituted for the foreclosure of this mortgage, or should the Mortgage become a party of any auti involving this Mortgage or the title to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of any attenney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagee, and a reasonable atterney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.
- (7) That the Mortgagor shall held and enjoy the premises above conveyed until there is a default under this mortgage or in the mote secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue.
- That the covenants herein contained shall hind, and the benefits and advantages shall inure to, the respective heirs, executors
