TO ALL WHOM THESE PRESENTS MAY CONCERN: CAINE COMPANY

(hereinafter referred to as Mortgagor) SEND (S) GREETING:

WHEREAS the Mortgagor is well and truly indebted unto THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA AS TRUSTEE AND EXECUTOR U/W WILLIAM S. LINDSAY (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty Seven Thousand Seventy One and 34/100 ----- DOLLARS (\$27,071.34) with interest thereon from date at the rate of 14 1/2% per centum per annum, said principal and interest to be repaid as follows: Payable in monthly installments, including principal and interest, of \$600.00 beginning on April 2, 1982 and on the 1st day of each month thereafter with the unpaid principal balance due and payable on March 31, 1983.

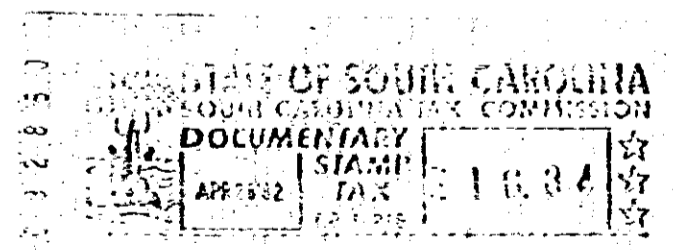
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its heirs, successors and assigns the following described piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon:

ALL that piece, parcel or lot of land in the City of Greenville, Greenville County, State of South Carolina, more particularly described as follows:

BEGINNING at an iron pin on the west side of Williams Street at the corner of a fifteen foot alley 200 feet south of North Street; thence S. 56-30 W. along said alley 155 feet to an iron pin; thence S. 15-1 E. 79.4 feet to an iron pin; thence N. 56-30 E. 155 feet to an iron pin on Williams Street; thence along Williams Street 19.4 feet to the beginning corner.
