Carolina (the "Lender") of the same date (the "Note") and covering the property described in the Security Instrument and located at . 112 Dorian Drive, Simpsonville, S. C. 29681.... Property Address Modifications. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows: A. INTEREST RATE AND MONTHLY PAYMENT CHANGES The Note has an "Initial Interest Rate" of 13..8 % The Note interest rate may be increased or decreased on the ist. day of the month beginning on . September 1983. and on that day of the month every .. months thereafter. Changes in the interest rate are governed by changes in an interest rate index called the "Index". The Index is the: [Check one box to indicate Index.] (1) O "Contract Interest Rate, Purchase of Previously Occupied Homes, National Average for all Major Types of Lenders" published by the Federal Home Loan Bank Board. (2) 23. One Year Treasury Bill. (Check one box to indicate whether there is any maximum limit on changes in the interest rate on each Change Date; if no box is checked there will be no maximum limit on changes.) (1)

There is no maximum limit on changes in the interest rate at any Change Date. *** (2) The interest rate cannot be changed by more than .2... percentage points at any Change Date. If the interest rate changes, the amount of Borrower's monthly payments will change as provided in the Note. Increases in the interest rate will result in higher payments. Decreases in the interest rate will result in lower payments. It could be that the loan secured by the Security Instrument is subject to a law which sets maximum loan charges **B. LOAN CHARGES** and that law is interpreted so that the interest or other loan charges collected or to be collected in connection with the loan would exceed permitted limits. If this is the case, then: (A) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (B) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note or by making a direct payment to Borrower.
