RETURN TO:

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mertgagee for such fur that sums as may be advanced hereafter, at the option of the Mertgage, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the cevenants herein. - (2) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction lean, that it will continue construction until completion without interruption, and should it fail to do so, the Martgagee may, at its option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
- (4) That it will pay, when dup, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against the mertgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged promises.

- (6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgagee, all sums then owing by the Moragagor to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgage become a party of any suit involving this Mortgage or the title to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of any attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagee, and a reasonable attorney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.
