NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing 1.80 acres, and being shown on a plat of the property of J. R. Williams and Bertha L. Williams recorded in the RMC Office for Greenville County in Plat Book UU at Page 47 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in Clearview Road on the line of the Greenville City Water Main and running thence along said Water Main, S.68-04 E. 183.9 feet to a point; thence S.07-55 W. 316 feet to an iron pin; thence S.15-40 E. 39 feet to an iron pin; thence N.87-55 W. 206.8 feet to a point in the center of said Road; thence with the approximate center of said Road, N.01-25 E. 235 feet; thence still with said Road, N.20-10 E. 190 feet to the point of beginning.
