That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the East side of Forest Street and the north side of Mountain View Avenue, and being Lot No. 15 of the W. Dennis Smith and H.J. Waters property according to survey and plat B4H.S. Brockman, Surveyor, dated June 8, 1950, recorded in Plat Book Y page 69 R.M.C. Office for Greenville County, and having the following courses and distances, to wit:
