Janice M. Posey (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto SOUTHERN BANK AND TRUST COMPANY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twelve Thousand and no/100

----- DOLLARS (\$12,000.00),
with interest thereon from date at the rate of 18 per centum per annum, said principal and interest to be repaid:

Due and payable in eighty four monthly installments of \$254.61, beginning September 8, 1982 and continuing on the same day of each month until paid in full, with the payments to be applied first to interest and then to principal.
