P. Owings made by John C. Smith and J. Coke Smith dated January, 1952, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book X at Page 36, and having according to a plat of a survey for P. H. Moore made by Jones Engineering Service dated January 24, 1972, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the common line of Lots 1 & 2 (said iron pin being located S.4-40W. 300 feet from an iron pin on the southern side of the right of way of U.S. Highway 123 at the joint front corner of Lots 1 & 2), and running thence through Lots 2 & 3, N.85-20W. 480 feet to a point on the common line of Lots 3 & 4, at the southwesternmost rear corner of property owned by Mary M. Moore, thence along the line of Lot 4, S.4-40W. 917.1 feet to an iron pin; thence along the lines of property now or formerly owned by Hopkins, Ritchie and Murphy, N.68-50E. 533 feet to an iron pin at the rear corner of Lots 1 & 2, thence along the common line of said lots, N.4-40E. 687.9 feet to an iron pin, the BEGINNING corner.
