

Ixing and being in the State of South Carolina, County of Greenville on the Northern side of Jannon Circle, being shown and designated as Lot No. 4 on Plat of Pine Brook Forest recorded in Plat Book 4X at page 45 and 47; being the property conveyed to the mortgagor bydeed of Nelms Brothers, Inc. dated December 23, 1977 and recorded in Dedd Book 1070 at page 725.
