To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that piece, parcel or lot of land situate, lying and being on the easterly side of Cashmere Drive near the city of Greenville, South Carolina, being known and designated as Lot No. 49 according to plat of the Pine Hill Village prepared by P.K. Campbell, PL3 July 9, 1962 as recorded in the DMC Office for Greenville County, South Carolina, in Plat Book 90 at page 169 and having according to said plat the following metes and bounds, to-wit: Beginning at an iron pin on the easterly side of Cashmere Drive at joint front corner of Lots 48 and 49 and running thence along the joint line of the said Lots N. 74-14 E 1.25 feet to an iron pin on the rear line of Lot 200; thence S. 15-46 E., 72 feet to an iron pin at the joint rear corner of Lots 48 & 49; thence along the joint line of line of the said lots S. 74-14 W. 125 feet to an iron pin on the easterly side of Cashmere Drive; thence along said Cashmere Drive N. 15-46 W. 72 feet to the point of beginning.



I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.



Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.
