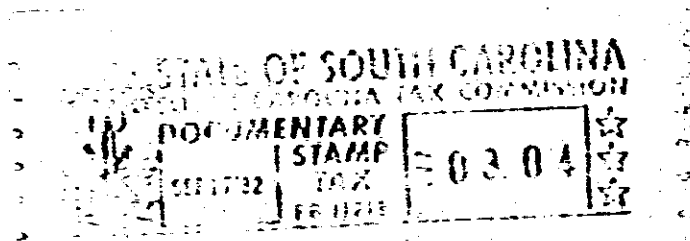
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Blake Street and shown as lot 39 of Section 3 on plat of Dunean Mills Village recorded in the R.M.C. Office for Greenville County in Plat Book S at Page 175, and described as follows:

BEGINNING at an iron pin on the western side of Blake Street at the joint front corner of lots 39 and 40, and running thence with the line of lot 40, S. 64-15 W. 136.6 feet to a pin on alley; thence with the eastern side of said alley, N. 25-46 W. 80.4 feet to a pin in the rear corner of lot 38; thence with the line of lot 38, N. 64-15 E. 136.6 feet to a pin on Blake Street; thence with the western side of Blake Street S. 25-46 E. 80.4 feet to the point of beginning.
