THIS MORTGAGE made and entered into the day and year written on the reverse side hereof by the Borrowers named above, herein called Mortgagors, to LANDMARK FINANCIAL SERVICES OF SOUTH CAROLINA, INC. berein called Mortgagee, the owner and holder of the Promissory Note referred to below.

WITNESSETH: THAT WHEREAS the Mortgagors are justly indebted to the Mortgagee for money loaned as evidenced by their Promissory Note of even date herewith executed and delivered by the Mortgagors to the Mortgagee in the amount of the Total of Payments stated above, which includes interest and charges as provided in said note.

AND WHEREAS, the Mortgagors desire to secure the payment of said debt and Note, and any renewals or extensions thereof, and the undertakings prescribed in this Mortgage by the conveyance of the premises hereinafter described.

THEREFORE, in consideration of the aforegoing and other good and valuable considerations, Mortgagors hereby give, grant, bargain, sell, assign and convey to Mortgagee, its successors and assigns, the following described real estate, together with all present and future improvements thereon, in South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Dunklin Township, and containing 1.11 acres, more or less, according to plat prepared by Anderson Surveying Associates, Inc. entitled "To be conveyed to Margaret Harkleroad", dated July 15, 1977, to be recorded in Plat book 6G, Page 13, R.M.C. Office for Greenville County, and having, according to said plat, following metes and bounds, to wit:

BEGINNING at an iron pin, which iron pin in the northwestern edge of a dirt road is approximately 370 feet northeast of the intersection of a 40 foot dirt road and Holliday Dam Road, and running thence N. 11-00 W., 160 feet to an iron pin; thence turning and running N. 68-43 E., 300 feet to an iron pin; thence turning and running S. 5-07 E., 118.65 feet to an iron pin in the northwestern edge of the aforesaid dirt road; thence along said dirt road, S. 34-08 W., 135.6 feet to an iron pin; thence continuing along said dirt road, S. 79-00 W., 186.8 feet to an iron pin, the point of beginning.

This conveyence is made subject to any restrictions, reservations, zoning ordinances, or easements that may appear of record or on the premises. This is the same property conveyed unto Essie Margaret Harkleroad by deed of William A. Henry dated August 1, 1977 and recorded in deed book 1061 at page 627.

TO HAVE AND TO HOLD the said land and premises, including all houses, buildings, improvements and fixtures thereon, with all rights, privileges and appurtenances thereunto belonging or appertaining to Mortgagee, its successors and assigns, in fee simple forever, upon the trusts and for the uses and purposes hereinafter set out, and the Mortgagors covenant with the Mortgagee that Mortgagors are seized of, and have the right to convey the premises in fee simple; that the premises are free and clear of all encumbrances, except a prior mortgage or such encumbrances as are set forth hereinabove; and that Mortgagors will warrant and defend the title to the premises against the lawful claims of all persons isoever. In the event of any default in the performance of any of the obligations of said prior encumbrances, the Mortgagee or assigns may make any payments or perform any acts necessary to reheve said default, and the cost thereof shall be added to the indebtedness hereby secured. Any such default in said prior encumbrances may at the option of the Medigagee or assigns, be deemed a default under this instrument. Mortgagors berein hereby assign and transfer unto Mortgagee, it successors and assigns, all surplus funds which come or be in the hands of the holder of any of said prior encumbrances upon foreclosure of the same, hereby directing that the same be forthwith paid over to Mortgagee or assigns upon the debt hereby secured.

THIS MORTGAGE also secures all future advances in the form of any renewal or refinancing of the aforesaid Promissory Note, which may from time to time be made by the Moltgagee to the Mortgagors; provided, however, that the making of any such future advances shall be at the sole option and discretion of the Mortgagee and upon such terms and colditions as it shall determine.

The Mortgagors further covenant and agree:

(4) To keep the premises in good order, repair and condition, reasonable wear and tear excepted, and to allow Mortgagee, at reasonable times, to inspect the premises.
