"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of _____

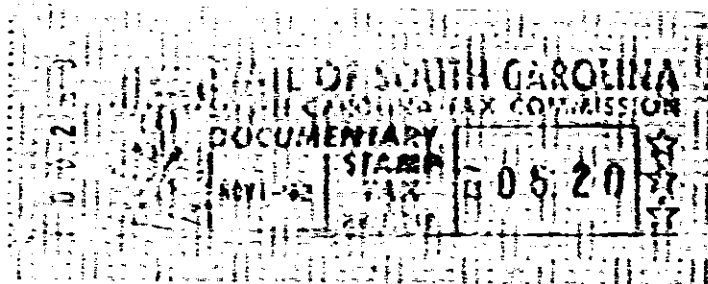
Greenville, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 11 on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County in Plat Book 5P, Pages 13 and 14 and being more particularly described as follows:

BEGINNING at a point at the joint corner of Units 11 and 12 and thence running S. 38-50 W., 17.5 feet; thence turning and running N. 51-10 W., 68.3 feet; thence turning and running N. 38-50 E., 17.5 feet; thence turning and running S. 51-10 E., 68.3 feet to the point of beginning.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
