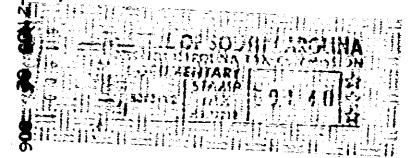

C. Smith by H. S. Brockman, Surveyor, dated May 25, 1936, and having the following courses and distances, to-wit:

BEGINNING on a stake on the north side of Snow Street, joint corner of lots 28 and 29, and running thence with the common line of these lots N. 9-03 E. 163.4 feet to a stake on the line of lot #27; thence with the line of lot #27 N. 69-37 W. 43.7 feet to a stake, corner of lot #26; thence with the line of lot #26 S. 16-38 W. 165 feet to a stake on the north side of Snow Street; thence with said street S. 73-22 E. 65 feet to the beginning corner.
