SUBORDINATION AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that I, D. STAN CROSBY, the owner and holder of that certain note and mortgage given by JEFFRY J. SCHENNING and CRISTEL F. SCHENNING to D. STAN CROSBY, in the original amount of Twelve Thousand (\$12,000.00) Dollars dated February 18, 1983, and recorded on Feb. 22, 1983, in the R.M.C. Office for Greenville County, S.C., in the Mortgage Book 1545, Page 645, do hereby postpone and subordinate the lien of my said mortgage and all of my rights, powers and privileges thereunder in favor of a certain mortgage from JEFFERY J. SCHENNING and CRISTEL F. SCHENNING to Bank of Travelers Rest in the amount of \$56,000.00 dated March 23, 1983, and recorded in the R.M.C. Office for Greenville County, S.C., in Mortgage Book 1549, Page 438.

AND in consideration of One Dollar in hand paid, receipt acknowledged and in further consideration of the granting of a mortgage loan by the said Bank to Jeffery J. Schenning and Cristel F. Schenning, I agree that my mortgage lien is and shall at all times be and remain junior, inferior and subsequent in priority to the lien of the aforesaid mortgage to Bank of Travelers Rest, or its assigns, but that the lien of my mortgage shall otherwise be unaffected by the Subordination Agreement
