THIS MORTGAGE is made this 18th day of July,  
1983, between the Mortgagor, Osborne W. Berry and Shirley M. Berry  
, (herein "Borrower"), and the Mortgagee, First Federal  
Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of  
the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein  
"Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty-Two Thousand  
Five Hundred and No/100 Dollars, which indebtedness is evidenced by Borrower's  
note dated July 18, 1983, (herein "Note"), providing for monthly installments of principal
