RIDER

(9) Mortgagor covenants and agrees that so long as any indebtedness is owed to Mortgagee under the terms and conditions of
the promissory note for which this Mortgage serves as security,
that Mortgagor will not use the subject premises for any purpose
except those specific purposes recited hereinbelow, which purposes
are hereby declared to be permitted uses of the subject property
by Mortgagor:

Light farming and/or agricultural
Day camp
Camp
Conference or retreat center
School
Lodge and other living quarters
Church
Parsonage
Activities center with ball fields

In the event Mortgagor violates any of the uses permitted under the within Mortgage, then, in such event, Mortgagee shall have the right to accelerate payment under the within Mortgage and declare all principal and accrued interest immediately due and payable, and shall thereafter have the right to foreclose said Mortgage under the default provisions contained therein.
