WHEREAS, I, Kenneth G. Henson

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of , Chick Springs Township, located on the Northwest side of Brannon Road and being shown on plat of property made for Roger Keith Henson by Terry T. Dill, recorded in plat book SSS page 143, and having the following courses and distances, to wit:

Beginning at a point on the northwest side of Brannon Road, which point is 369 feet from corner of two roads, both known as Brannon Road and running thence N. 48-33 W., 177 feet; thence N. 37-27 E., 115 feet; thence S. 48-33 E., 179.4 feet to pint on Brannon Road; thence with Brannon Road, S. 38-40 W., 115 feet to the beginning corner.
