#### (B) The Index

Any changes in my rate or interest will be based on changes in the Index. The "Injex" is the weekly auction average rate on United States Treasury bills with a raturity of o months, as made available by the Federal keserve Found. The most recently available Index figure as of the date 45 mays before each Interest Change Date is called the "Current Index." As of the date hereof, the Current Index is 8.84.

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give me notice of this choice.

# (C) Calculation of Interest Rate Changes

Before each Interest Change Date, the Note Holder will calculate my new rate of interest by adding 3.535 percentage points (3.535°) to the Current Index. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125°). This rounded amount will be my new rate of interest until the next Interest Change Date.

### (D) Interest After Default

The rate of interest required by this Section 2 is the rate I will one both before and after any default described in Section 10(3) or the Note.

### 3. CALCULATION OF AMOUNTS OWED EACH MONTH

The Note Holder will calculate my Full Payment Amount annually as set forth in Section 5. The "Full Payment Amount" is the amount of the monthly payment that would be sufficient to repay the amount I originally borrowed, or the unpaid principal bilance of my loan as of every other Interest Change Date, in full at the rate of interest I am required to pay by Sections 2(A) and 2(C) above in substantially equal payments on October 1, 2013, which is called the "maturity date." Beginning on the date of this Note, my first Full Payment Amount will be U.S. 5 637.71 until the first Interest Change Date. Before every other interest Change Date, the Note Holder will calculate the new Fill Payment Amount which I will owe each month beginning on the first monthly payment date after such Interest Change Date.

The Full Payment Amount I owe may be more or less than the amount I am required to pay each menth. Section 5 below states the amount of my monthly payment and how it will change.
