THIS MORTGAGE is made this 26th day of October 1983, between the Mortgagor, Patricia I. Cooper

(herein "Borrower"), and the Mortgagee, N. Barton Tuck, Jr. as Nominee for the Trustees of U. S. Shelter, a ~~corporation organized and existing under the laws of~~ Massachusetts Business Trust, whose address is P. O. Box 6725, Sta. B., Greenville, South Carolina 29606 (herein "Lender").
