To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that piece, parcel and lot of land, situate, lying and being in Oneal Township, in the County of Greenville, State of South Carolina, about three miles north of the City of Greer on the western side of Holiday Road, and according to a plat prepared by John A. Simmons, October, 15, 1960, has the following metes and bounds, to-wit:

BEGINNING at a nail in the center of Holiday Road at the corner of property now or formerly of Clarence E. Mitchell, et al, (iron pin on western bank of road at 22 feet from truer corner) and running thence with the center of said road, N. 18-55 E. 137 feet to a nail (iron pin on western bank at 22 feet); thence S. 83-45 W. 384.5 feet to iron pin; thence S 6-15 E. 124 feet to an iron pin at the corner of Mitchell Road; thence with that line, N. 83-45 E. 326.7 feet to iron pin, the point of beginning.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.
