The Mortgagoe further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the convenants herein. - (6) That if their is a default in any of the terms, conditions, or corenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgagee all sums then swang by the Mortgagor to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed.
