The Note provides for an Initial Rate of Interest of 11.375 c. Section 4 of the Note provides for changes in the interest rate and the monthly payments, as follows:

"(A) Change Dates Beginning in 19.84, the rate of interest I will pay may change on the 1st day of the month of and on that day every 6th 12th 30th 66th /Check only one box/month thereafter. Each date on which the rate of interest could change is called a "Change Date"

Any changes in the rate of interest will be based on changes in the Index. The "Index" is the monthly average yield on United States Treasury securities adjusted to a constant maturity of [6 months] 1 year] 3 years] 5 years as made available by the Federal Reserve Board, or [] the "Contract Interest Rate, Purchase of Previously Occupied Homes, National Average for all Major Types of Lenders" as made available by the Federal Sieme Loan Bank Board.

The Margin between my rate of interest and the Index Rate will be 2.25 Z.

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give me notice of this choice.

The first Index figure for this Note is 9,050 ... It is called the "Original Index."

The most recently available Index figure as of the date. 45...... days before each Change Date is called the "Current incex."

(C) Calculation of Changes

Before each Change Date, the Note Holder will determine any change in my rate of interest. The Note Holder will calculate the amount of the difference, if any, between the Current Index and the Onginal Index. If the Current Index is higher than the Original Index, the Note Holder will add the difference to the Initial Rate of Interest. If the Current Index is lower than the Original Indea, the Note Holder will subtract the difference from the Initial Rate of Interest. The Note Holder will then round the result of this addition or subtraction to the nearest one-eighth of one percentage point (0.125%). This rounded amount will be the new rate of interest I am required to pay.

The Note Holder will then determine the new amount of my monthly payment that would be sufficient to repay the outstanding principal balance in full on the maturity date at my new rate of interest in substantially equal payments.
