Leslie by Carolina Surveying Co., dated June 6, 1983 being recorded in the RMC Office for Greenville County in Plat Book 9-U, at Page 6, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Rock Creek Drive at joint front corner of Lots 9 and 10, said pin also being 272 feet in a southeasterly direction from the point where the northeast side of Rock Creek Drive intersects with the southeast side of Mount Vista Avenue, and running thence with the line of Lot No. 10 N. 35-06 E., 322 feet to a point on the southwest edge of Reedy River; thence along the southwest edge of Reedy River S. 54-0 E., 80.4 feet to an iron pin on the southwest edge of Reedy River; thence through Lots 8 and 9 S. 27-33 W., 295.7 feet to an Iron pin on the northeast side of Rock Creek Drive; thence with the northeast side of Rock Creek Drive N. 69-26 M., 23 feet to an iron pin; thence continuing with Rock Creek Drive N. 67-43 W., 100 feet to the beginning corner.
