
fifteen (15%) per cent of the unpaid debt, and court costs incurred in collection of amounts due hereunder, and Expenditures by Mortgagee under paragraph 5 below. Interest under the Note will be deferred, accrued or capitalized, but Mortgagee shall not be required to defer, accrue or capitalize any interest except as provided in the Note.

THIS MORTGAGE is given to secure to Mortgagee the repayment of the following amounts, with interest. (a) the indebtedness evidenced by the Note, (b) any Future Advances made under paragraph, 13 below, (c) Expenditures by Mortgagee under paragraph 5 below, and (d) attorneys' fees, court costs and other amounts which may be due under the Note and this Mortgage. In consideration of the above indebtedness and for other valuable consideration which Mortgagor acknowledges receiving. Mortgagor does hereby mortgage, grant and convey to Mortgagee, and the Mortgagee's heirs, successors and assigns, the following described property:

ALL that certain piece, parcel or tract of land, together with all improvements thereon, containing 1.6 acres, more or less, situate, lying and being in the County of Greenville, State of South Carolina, on the Eastern side of Haywood Road, and being shown and designated on plat recorded in the RMC Office for Greenville County, S. C. in Plat Book 4-F, at Page 62, as property of Jennings Cook, and being more particularly shown on plat prepared for E. F. DuBois by Clifford C. Jones, RLS, dated May 23, 1933, and recorded in the RMC Office for Greenville County, S. C. in Plat Book 9-R, at Page 56, and having, according to said plats, the following metes and bounds:

BEGINNING at an iron pin on the Eastern edge of Haywood Road, said iron pin being 400 feet Southwest of Haywood Crossing Drive, and running thence, S. 75-31 E. 439.5 feet to an iron pin in or near a branch; thence turning and running along the center line of said branch, the traverse line of which is S. 1-11 W. 154.34 feet to an iron pin; thence turning and running, N. 75-31 W. 475.0 feet to an iron pin in the Eastern edge of Haywood Road; thence along edge of said road, N. 14-29 E. 150.2 feet to the point of beginning.
