"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

ALL that piece, parcel or lot of land, together with all buildings and improvements, situate, lying and being on the eastern side of Rockvale Drive, in Gantt Township, Greenville County, South Carolina, being shown and designated as Lot No. 198 on a plat of ROCKVALE, Section 2, made by J.
