THIS MORTGAGE is made this 17th day of FEBRUARY,
1984, between the Mortgagor, JOHN O. BESSENT AND MELBA P. BESSENT

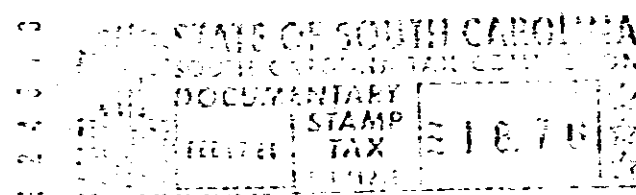

ALL that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina and being known and designated as Lot 117 on a Plat of Del Norte Estates recorded in Plat Book "WWW" at Pages 32 and 33 and being further shown on a Plat of Property of John O. Bessent and Melba P. Bessent recorded in Plat Book 10-H at Page 74, R.M.C. Office for Greenville County, South Carolina and having, according to the latter Plat, the following metes and bounds, to-wit:
